Dear Parents,

The Ministry of Education, Government of India has decided that all the students should have Aaar ID & such Aaar ID will be lifelong.

The benefit of the Aaar Card as per Government of India will be as follows:

- 1) Unified Tracking: Comprehensive monitoring of the students educational journey and enhancing learning outcome.
- 2) Digital Integration: Aaar ID will be linked to Digilocker wherein students can digitally store documents etc.
- 3) Seamless Transition: Smooth transition of academic records when students move between schools.
- 4) Visualization of Learning Pathway Through VSK: Aaar ID will be linked with the IT system and thereby micro analysis can be done.

Aaar ID Card will also be linked with the Aadhaar Card.

Aaar ID will be generated through UDISE plus Portal.

Accordingly, the officers of Government of India and the State Government can view all the personal data including educational journey of the Students & Parents.

You are aware that Government of India has enacted the IT Act & DPDP Act 2023 which mandates that personal data of the students can be collected & stored after taking the consent from the concerned Parents / Individual.

In view of the direction by Ministry of Education, the Education Department, Government of Maharashtra has advised schools to take the consent of the Parents for creating the Aaar ID.

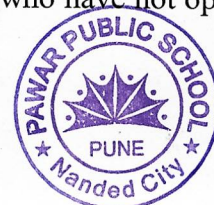

It may be noted that **if Parents do not want to share their personal data** with various competent authorities of Government of India and State Government, they may intimate to the school that they are not interested to create the Aaar ID. **Letter from Parents (Annexure B)**
