1. Eligibility Criteria for admission:

2. Admission Forms for Std. V

- There are limited seats available for Std. V (against cancellation only)
- Forms will be available <u>ONLINE ONLY</u> to ALL ELIGIBLE candidates. www.ppsnandedcity.com The cost of the form is ₹ 2000/- (Non-refundable)
- The online Admission Forms for Std. V will be available from 12:00 noon on Saturday, 15th June 2024. Candidates will have to show the receipt of online payment of admission form fee and bonafide certificate along with U-DISE+ Number and SARAL ID of the student is mandatory of the previous school to appear for the activity.
- For Std. V admissions will be given only on merit basis.
 - There will be an activity paper for students seeking admission for Std. V. The activity paper will be taken for English and Mathematics. Each paper will be of **20 marks**. The activity will be based on the previous Std's syllabus. Admissions for Std. V will be based on the performance in the activity and passed and promoted certificate of previous Std. of previous school.
- Activity paper of 1 hour will be conducted on Saturday, 22nd June 2024 at 10.00 a.m. in school premises. Form numbers of selected students in merit list will be declared on 25th June 2024 at 03:00 pm on website and notice board.
- Only parents of candidates whose names are selected in merit list of activity will be informed by phone call and form number list will be displayed on notice board.
- Admission for Std. V will be treated as provisional till the receipt of the Original School Leaving / Transfer Certificate from the previous school. The last date for submission of the same is Monday, 15th July, 2024.

3. <u>Documents to be submitted along with the completely filled and signed printouts of the Selected Online Admission Form (Std. V):</u>

Admission will be confirmed only after the fees are paid and all documents submitted. You should submit the following list of documents at the time of Admission:

- i) A self-attested copy of the Birth Certificate, in English with the Child's Name, Mother's Name and Father's Name clearly mentioned. (Mandatory for all classes)
- ii) Four passport size (35mm x 35mm) latest colour photographs of the child properly affixed on the place provided on the printout of the Admission Form and group photo of family (Mother, Father of child and child)Size for family photo: 6"x 4" with plain white background.
- iii) For Std. II onwards previous School's bonafide certificate along with U-DISE + number and SARAL ID of the student is mandatory.
- iv) No dues certificate from the previous school. (Mandatory).
- v) The Original School Leaving/ Transfer Certificate from the previous school.
- vi) Proof of Residence (Local): A self-attested copy of residence proof. Residence proof should be strictly in the name of the father, mother or grandparents of the child seeking admission

 Any ONE of the following documents can be produced as proof of residence:
 - a. Passport (Recent)

- **b.** Electricity Bill (Recent)
- c. Registered Sale / Rent Agreement Copy (Recent)
- d. Aadhaar Card

e. Bank statement for the current month

- f. Telephone Bill (Land Line)
- vii) For Std. II to Std. VIII a self-attested copy of the mark sheet of the previous Std. from the previous school. In case of student migrating from other countries, Indian Embassy stamp is mandatory on Transfer Certificate.
- viii) The Medical Certificate provided in the printout of online Admission Form has to be completely filled, signed and stamped by a Registered Medical Practitioner.
- ix) Photocopy of Passport / OCI card (for students migrating from outside India).
- x) Parents from the Reserved Category, who want the caste to be entered in the school register should submit a self-attested copy of the Caste Certificate in the name of the student and issued by the concerned Government Authorities at the time of admission.
- xi) A self-attested copy of the student's aadhaar card and both the parents' aadhaar card is mandatory.
 - > You are requested to carry all the original documents for verification.

4. Payment of Fees for new Students of Std. V:

- > Fees will not be accepted without submission of all the required documents.
- > Details of Fee Structure for the academic year 2024-25 are displayed on the school notice board and attached with notice.
- > Fees have to be paid through a <u>Demand Draft or UPI only</u> in the administration office of the school at the time of submission of the printouts of the admission form and the other documents.

At the time of admission two separate **Demand Draft or UPI only** have to be submitted in favour of "**Pawar Public School, Nanded City**" as follows:

1) "Pawar Public School, Nanded City" for ₹ 55,000/- (Interest Free) towards Refundable Caution Money Deposit,

And

- 2) <u>Full Annual fees</u> ₹ **66,510/-** (Admission Fees,1st quarter, 2nd quarter, 3rd quarter, 4th quarter) will have to be paid at time of admission.
- 3) PTA fees: Fees have to be paid through Cash / Cheque in favour of "PPS Nanded City PTA Account" for ₹ 50/- towards Parent Teacher Association.
- 4) Students taking admission in any month after April 2024 have to pay the fees from month of admission.

5. Cancellation of Admission:

- 1) Those parents who wish to cancel the admission of their ward should give a written application signed by both the parents/ guardians who signed the admission form, seeking cancellation of admission.
- 2) Only the Caution Money Deposit (Interest Free) & ONLY 3rd & 4th quarter fees will be refunded to those who seek cancellation of admission before 31st July 2024.
- 3) The application for withdrawal has to be accompanied by an application for the refund of caution money along with the original caution money receipt stating the name in which the refund cheque has to be issued. The caution money deposit amount will be refunded to the applicant **after 21 working days**, from the receipt of the application.
